Information We Collect

- Any other personal data you choose to submit.

We also automatically collect certain non-personal information when you visit our site, such as:

This information is collected through cookies and similar technologies, including Google Analytics.

How We Use Your Information

We may use your information to:

- Communicate with you about our work, initiatives, and opportunities to support our mission
- Process your donations
- Respond to your inquiries or requests
- Improve our website and analytics

- Comply with legal obligations

Sharing of Information

We do not sell or rent your personal information to third parties. We may share your information:

- With service providers who assist in our operations (e.g., payment processors, email providers)
- When required by law or legal process
- To protect our rights, privacy, safety, or property

Use of Google Analytics

We use Google Analytics to understand how visitors engage with our website. Google Analytics collects data using cookies and similar technologies to track user interactions. This data may include:

- IP address
- Browser type
- Time spent on pages
- Links clicked
