**JOINT STIPULATION OF DISMISSAL WITH PREJUDICE**

COMES NOW, Plaintiff Southeastern Legal Foundation (Plaintiff or SLF) and Defendant United States Department of Justice (Defendant or DOJ), by and through their respective counsel of record, and pursuant to Fed. R. Civ. P. 41(a)(1)(ii), file this Joint Stipulation of Dismissal with Prejudice of all remaining claims asserted in this action against Defendant.

Plaintiff filed two Freedom of Information Act lawsuits in the summer of 2019 seeking records from the DOJ, *Southeastern Legal Foundation, Inc. v. United States Dep't of Justice*, No. 1:19-cv-3215 (N.D. Ga. 2019) (“Case No. 3215”), and the Federal Bureau of Investigation (FBI), *Southeastern Legal Foundation, Inc. v. United States Dep't of Justice*, No. 1:19-cv-3429 (N.D. Ga. 2019) (“Case No.

3429”). On August 23, 2021, the Court consolidated the two cases and directed all future filings to occur only in Case No. 3215. (Case No. 3429, Doc. 52, Page ID #2.) The Court also ordered the clerk to administratively close Case No. 3429. (Id.)

On March 31, 2022, the Court issued an order granting the DOJ’s Motion for Summary Judgment and denying SLF’s Motion for Summary Judgment. (Case No. 3215, Doc. 57, Page ID #19.) It directed the clerk to refrain from terminating the case because the issues raised in Case No. 3429 were still pending. (Id.)

Plaintiff and Defendant now file this Joint Stipulation of Dismissal with Prejudice of all remaining claims asserted in this action against Defendant.
